

1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Hadbrok Insurance Brokers S.A.E ("**Company**", "**we**", "**us**", or "**our**"), concerning your access to and use of the <http://www.hadbrok.com> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). We are registered in Egypt and have our registered office at Villa 6 Street 213, Cairo 414411. The Site provides an online marketplace for the following goods, products, and/or services: Insurance products (the "Marketplace Offerings"). In order to help make the Site a secure environment for the purchase and sale of Marketplace Offerings, all users are required to accept and comply with these Terms of Use. You agree that by accessing the Site and/or the Marketplace Offerings, you have read, understood, and agree to be bound by all of these Terms of Use.
